



Raffaella Nigro is Full Professor of International Law at the Department of Law, Economics and Sociology (Dipartimento di Giurisprudenza, Economia e Sociologia, DIGES) of the University 'Magna Græcia' of Catanzaro. She was Postdoctoral Researcher (Ricercatore) at the Universities of Salerno (2012) and Perugia (2013-2016) and Visiting Researcher/Fellow at the Max Planck Institute for Comparative Public Law and International Law (2007, 2018) and the Lauterpacht Centre for International Law (2008-2009). Her current research interests and publications centre around human rights, functional immunity, international terrorism and international criminal justice. Among other publications, she authored two monographs: *La definizione di terrorismo nel diritto internazionale* (Editoriale Scientifica, 2013) and *Le immunità giurisdizionali dello Stato e dei suoi organi e l'evoluzione della sovranità nel diritto internazionale* (Wolters Kluwer/Cedam, 2018).

Emma Luce Scali is Lecturer in Law and Co-Director of the LLMs International Law and International Human Rights at the School of Law of Birmingham City University, where she leads the modules on Public International Law and EU Law. Her current research interests and publications centre around human rights, sovereign financing and the global economic order. Among other publications, she authored a monograph on *Sovereign Debt and Socio-economic Rights Beyond Crisis: The Neoliberalisation of International Law* (CUP, 2022). Dr Scali has significant research experience also outside academia, having worked with various civil society organisations and the public sector. In 2022/23, she was consultant researcher for the UN Independent Expert on Foreign Debt and Human Rights, and OHCHR SEARO (Office of the United Nations High Commissioner for Human Rights, South-East Asia Regional Office).
